

Dansk Muslimsk Center (DMC)

Recurring Donation Agreement

1. Purpose of the Agreement

By signing up for a recurring donation, the Donor authorises Dansk Muslimsk Center (DMC) to collect a monthly donation, through the chosen payment method, to support DMC's religious, educational, charitable, and community activities.

2. Organisation

DMC is a religious community ("trossamfund") officially recognised by the Danish Ministry of Ecclesiastical Affairs (By-, Land- og Kirkeministeriet).

3. Donation Amount and Collection

- The Donor chooses the monthly donation amount when creating the subscription.
- The minimum recurring donation is DKK 100 per month. There is no fixed maximum.
- The donation amount is deducted automatically every month, on the date the subscription was created (or the nearest available date), until the Donor cancels it.
- Where available in the MobilePay app, the Donor may select a preferred monthly payment date.

Donations are voluntary. Once a monthly payment has been collected, it is generally non-refundable, except where required by law.

4. Payment Method

The recurring donation is processed through MobilePay (Vipps) subscriptions, or such other payment methods as DMC may offer from time to time. The Donor is responsible for ensuring that sufficient funds are available on the selected payment account on the scheduled collection date.

5. Right to Cancel or Withdraw

- The Donor can cancel, pause, or change the recurring donation at any time, free of charge, directly in the MobilePay app (under "Subscriptions" / "Faste betalinger").
- No notice period and no reason is required.
- Cancellation takes effect from the next scheduled payment; it does not refund amounts already collected, except where required by law.

The MobilePay app is the definitive way to cancel or change a subscription. If the Donor has trouble doing so, DMC can be contacted using the details in Section 7 for help, but changes to the subscription itself are made by the Donor in the app.

6. Processing of Personal Data

DMC processes personal data in accordance with applicable data protection legislation, including the General Data Protection Regulation (GDPR). Information provided by Donors is used solely for: administration of the donation; communication regarding the donation agreement; accounting and legal obligations; and, where applicable, tax-related reporting.

To process the recurring donation itself, MobilePay/Vipps shares only the information needed to identify the transaction (name and donation amount) with DMC, in line with MobilePay's own terms and privacy policy.

Where a Donor asks for a tax-deduction receipt ("skattefradrag"), DMC will additionally ask for the Donor's **name, donation amount, and CPR number**. This information is used solely to report the donation to the Danish Tax Agency (Skattestyrelsen) for the Donor's annual tax statement ("årsopgørelse"). It is stored internally by DMC for this purpose only, treated as confidential, and kept for no longer than required by law.

Personal data will not be sold or shared with unauthorised third parties. Donors have the right to lodge a complaint about DMC's processing of personal data with the Danish Data Protection Agency (Datatilsynet), in addition to contacting DMC directly.

9. Effective Date

This recurring donation agreement becomes effective when the Donor completes the registration and the first payment authorization is successfully established.

10. Governing Law

This Agreement is governed by Danish law.
